#### 10.01 HEALTH OFFICER

- (1) How selected. See s. 2.02 of this code.
- (2) The Crawford County Duties. The Crawford County Health Officer under the supervision of the district State Health Officer shall:
  - (a) Make a periodic sanitary inspection annually of all school buildings, restaurants, dairies, grocery stores, meat markets and places of public assemblage and report thereon to those responsible for the maintenance thereof.
  - (b) The Crawford County Health Officer investigates violations the health laws, rules and regulations of the State Board of Health, the State and the Village, including the laws relating to contagious diseases contained in ch. 252, Wis. Stats. The Crawford County Sheriff Office enforces violations when the Crawford County Health Officer finds.
  - (c) Take steps necessary to secure prompt and full reports by physicians of communicable diseases
  - (d) Keep and deliver to his/her successor a record of all his/her official acts.
  - (e) Crawford County Health Officer reports to the State Board.
- (3) Village Health Officer Duties.
  - (a) Make annual sanitary survey and maintain continuous sanitary supervision over his/her territory.
  - (b) Keep and deliver to his/her successor a record of all his/her official acts.

#### 10.02 MILK AND MILK PRODUCTS

No person shall sell, offer or expose for sale within the Village any milk or milk product other than Grade A pasteurized milk or milk products as defined in Ch. AG 80, Wis. Adm. Code.

## 10.03 COMPULSORY CONNECTION TO SEWER AND WATER

Whenever sewer and water becomes available to any building used for human habitation, the Village Health Officer shall notify in writing the owner, agent or occupant thereof to connect all facilities thereto required by the Health Officer. If such person to whom the notice has been given shall fail to comply for more than 10 days after the notice, the Health Officer shall cause the necessary connections to be made and the expense thereof shall be assed as a special tax against the property pursuant to sec. 281.45, Wis. Stats.

#### 10.04 KEEPING OF ANIMALS AND FOWL

- (1) Sanitary Requirements. All structures, pens, buildings, coops or yards located on property within the corporate limits of the Village of Ferryville where animals or fowl are kept and so permitted in conjunction therewith shall be maintained in a clean and sanitary condition free from rodents, vermin and objectionable odor.
- (2) Animals Excluded from Food Handling Establishments. No person, firm, corporation nor entity shall take pr permit any animal, fowl, or reptile on or upon any premises within the corporate limits of the Village of Ferryville. Crawford County, Wisconsin, where food is sold, offered for sale or processed for consumption by the general public. This subsection does not apply to service animals as defined by ss 106.52, Wis. Stats., or any amendments to same. (repealed and recreated January 19, 2022)

## 10.05 REGULATION OF WEEDS, GRASS, AND NATURAL GROWTH

- (1) Subject to paragraph (2) & (5) below, no owner or occupant of any land within the Village limits of the Village of Ferryville, Crawford County, Wisconsin, shall permit grass, weed, or other natural growth, other than trees or shrubs, to grow to a height of more than 8 inches. In the event the owner and/or occupant of any land within the Village limits of the Village of Ferryville, Crawford County, allows any grass, weeds, or other natural growth, other than trees or shrubs, to grow to a height of more than 8 inches, the Village President or someone appointed by the Village Board shall give written notice to the owner and/or occupant of said land to cut said grass, weed, or natural growth within 10 days of date of said Notice. In the event the owner and/or occupant fails to comply with said Notice, The Village President or the individual appointed by the Village Board as above referred to shall order the Public Works Director to enter upon said premises and cut said grass, weeds, or natural growth, and the cost of the same shall be charged to the property owner and collected as a special assessment against the premise to which shall be collected as other taxes when real estate taxes are collected. The Public Works Director may contract, as required, to complete the mowing.
- (2) Notwithstanding paragraph (1) above, it shall be lawful for and paragraph (1) above shall not apply to any owner and/or occupant of land within the Village Limits of the Village of Ferryville, Crawford County, Wisconsin who has on file with the Village of Ferryville a "Plan" approved by the Village Board for the Village of Ferryville to actively manage land utilizing natural landscaping or wildlife

landscaping practices to grow native, naturalized, or surrogate plants, including ferns, wildflowers, or other flowering plants or grasses. A "Plan" as herein referred to shall consist of a letter or other documented addressed to the Village Board for the Village of Ferryville, Crawford County, Wisconsin, in c/o the Village Clerk, together with a non-refundable processing fee of \$30.00, therein indicating interest to actively manage land through natural landscaping or wildlife landscaping practices and shall include sufficient detail and information to permit a clear understanding of the owner's and /or occupant's intent, method, and implementation of said "Plan". Said "Plan" shall be reviewed and acted upon by the Village Board within 45 days of delivery of same to the Village Clerk and written notice of acceptance or rejection of same shall be given in writing to the owner and/or occupant submitting same no later than 50 days after delivery of same. Further, any "Plan" accepted by the Village Board shall remain valid and in effect from date of written notification of acceptance or until revoked by the Billing Board as hereinafter set forth. Lands specified in the "plan" shall have growth cut once annually in the autumn period of the year and no later than November 15th of each year.

- (3) All "Plans" referred to in paragraph (2) above shall in addition to the requirements set forth above comply with all provisions of Sec. 66.0407. WIs. Stats, now in effect or an amendments there to relating to the control of noxious weeds.
- (4) In the event any premises covered by a "Plan" that is accepted by the Village Board is not maintained by the owner and/or occupant of said premises in accordance with the specifications set forth in said "Plan", shall upon 10 days written notice by the Village Board to the owner and/or occupant of the land for which the "Plan" was submitted, be placed into compliance with the specifications of said "Plan" as approved and upon the failure of the owner and/or occupant to so comply within the time period herein specified, the "Plan" shall be automatically revoked and the Village President or someone appointed by the Village Board shall order the Public Works Director to enter upon said premises and cut or remove all growth on said premises and the cost of same shall be charged to the property owner and collected a s a special assessment against the premises. The Public Works Director may contract, as required, to complete the mowing.
- (5) Notwithstanding paragraph (1) above, it shall be lawful and paragraph (1) above shall not apply to the owner of any land within the Village of Ferryville, Crawford County, Wisconsin if:
  - (a) The property is one (1) or more acres in size and not visible at any time of the year from State Highway 35;
  - (b) The property adjoins Crawford County Highway C, and is not visible at any time of the year, from State Highway 35;
  - (c) The property is located in the Eagle Mt. subdivision, but not a lot included in 1 South thru 9 South.
  - (d) The property owner is compliant with the sec. 66.0407m WI Stats., now in effect of amendments thereto relating to the control of noxious weeds.
  - (e) The land owner cuts any grass, weeds or other natural growth, other than trees or shrubs, to a height of less than 8 inches once annually in the autumn period of the year and no later than November 15th.

- (6) Owners of lands, as defined in paragraph (5) above are subject to the provisions of the cutting grass, weeds or other natural growth, other than trees or shrubs, following the required notice from the Village President or someone appointed by the Village Board, and in the event of non-compliance the provisions of paragraph (1) shall apply.
- (7) Any person violating any prevision of the Ordinance, in addition to the remedial costs referred to in paragraphs (1), (4) and (5) above shall be subject to the penalty provisions of Section 13.04 of the Municipal Code of the Village of Ferryville, Crawford County, Wisconsin.

### 10.06 STANDARD FOR GARBAGE USER COLLECTION

Real Estate with development will be charged the current refuse assessment fee. This fee is charged whether collection is used or not.

## 10.07 RIGHT OF HEALTH OFFICER TO ENTER PREMISES

The Village Health Officer or the Crawford County Health Officer shall have the right to enter and examine any public premises or any place here meat, fish, poultry, game, milk, bakery goods or other foodstuffs are stored, prepared or dispensed for public consumption and to inspect or examine any vehicle transporting such foodstuffs for the purpose of enforcing the provisions of the chapter. Any person who shall hinder, obstruct or prevent the Village Health Officer or the Crawford County Health Officer from entering or carrying out his examination of such premises or vehicle shall upon conviction there of forfeit no less than \$10 nor more that \$100 together with the costs of prosecution and in default if payment of such forfeiture or costs shall be imprisoned in the county jail until such forfeiture and costs are paid by not exceeding 60 days.

## 10.08 ABATEMENT OF HEALTH NUISANCES.

The Village Health Officer or the Crawford County Health Officer together with Board of Health shall have the power to bate health nuisances in accordance with S. 254.59 Wis. Stats. Which is here by adopted by reference and made a part of this section as if fully set forth herein.

#### 10.09 PENALTIES.

The penalty of violation of any provision of this chapter shall be a penalty as provided in S. 13.04 of this code. A separate offense shall be deemed committed on each day on which a violation occurs or continues, provided no forfeiture shall be imposed for a violation of S. 10.03 when connection to sewer or water main is enforced at the expense of the property owner.
