WHEREAS, a Resolution was introduced and read at a regular meeting of the Village Board of the Village of Ferryville, Crawford County, Wisconsin, held on the 18th day of February, 2026, providing that the following street be vacated:

All that part of Elm Street lying north of Maple Street and south of Parcel Number 12-126-0140-0000 located in the Village of Ferryville, Crawford County, Wisconsin.

WHEREAS, a Lis Pendens has been duly filed in the office of the Register of Deeds for Crawford County, Wisconsin, as required by law.

NOW, THEREFORE, Be it, By the Village Board of the Village of Ferryville, Crawford County, Wisconsin, RESOLVED:

Section 1: That a public hearing on said Resolution shall be held at the Village Hall located in the Village of Ferryville, Wisconsin, on the 15th day of April, 2026, at 6 o'clock P.M., on said date, at which time all interested persons shall be heard and at which time said Village Board will meet and act upon said Resolution.

Section 2: That the Village Clerk for the Village of Ferryville, Crawford County, Wisconsin, shall cause notice of said hearing to be posted in three (3) public places in the Village of Ferryville for three (3) consecutive weeks prior to the date of said hearing, and shall also cause such notice to be served upon all owners of all of the frontage of lots and lands abutting upon the right of way sought to be vacated, all as required by Section 66.1003 of the Wisconsin Statutes.

BE IT RESOLVED by the Village Board of the Village of Ferryville, Crawford County, Wisconsin:

1. The Village Board hereby declares its intention to exercise its power under Section 66.1003 of the Wisconsin Statutes to vacate and discontinue use of the following described street:

All that part of Elm Street lying north of Maple Street and south of Parcel Number 12-126-0140-0000 located in the Village of Ferryville, Crawford County, Wisconsin.

2. That any final Resolution adopted pursuant hereto shall reserve to the Village an easement to maintain the public utilities as are now located and installed within said described premises and an easement to place, install and maintain public utilities within said described premises in the future.

3. That attached to this Initial Resolution and made a part hereof is a Plat showing that certain street above referred to, said street being shown in red.
